



- I. Call to Order
 - a. E. Winarto called the meeting to order at 5:31 pm.
 - b. *Members Present:* R. Adityavarman, K. Angierski, R. Boylan, C. Cannarozzo, A. Gagnon, J. Goldberg, R. Harrison, J. Hernandez, M. Jodlowski, C. Little, A. Loiben, T. McCann, A. Schofield, C. Stambuk, W. Zhang.
 - c. *Members Absent:* S. Hesse, E. Michel, D. Moon.
 - d. *Also Present:* B. Knuth, J. Malina.
- II. Approval of the Minutes
 - a. A motion was made to table approval of the minutes, there was no dissent (the minutes passed later during Open Forum).
- III. Presentations
 - a. Barbara Knuth, Dean of the Graduate School, then made her presentation on the impact of the proposed Congressional tax plan on Cornell graduate students.
 - i. The provision of greatest concern is the repeal of IRS code section 117.d in the House bill. There's a lot of uncertainty and a lot of process that needs to unfold. Repealing 117.d would not affect Cornell graduate students, but it would have a large effect on graduate education in the country as a whole. Cornell is lobbying very strongly against 117.d repeal.
 - ii. J. Malina: Cornell has an office of Federal relations. All of these lobbying efforts have begun to have an impact, but we should know in the next week or two if they worked. They are hearing receptivity in New York Republican congress people's offices, except for Tom Reed. They are trying to convince three senators to be "no" votes, and if that doesn't work they will try to get the language out of the conference bill.
 - iii. A. Gagnon asked for clarification on how Cornell students are classified.

- iv. B. Knuth: assistantships and fellowships, the tuition credit, is treated as a qualified scholarship under 117.a-c, and that section is not being slated for repeal.
 - v. A. Waymack: is it reasonable to expect Congress wouldn't go after our exemption? How come only a few schools take this loophole? (Cornell, Iowa, Notre Dame).
 - vi. If this bill passes, there will be a multi-year process trying to figure out this mess.
 - vii. M. Battaglia: are there any other sections that Cornell is worried about in this tax bill?
 - viii. J. Malina: the excise tax on University Endowment funds is troubling. Cornell's team has estimated that the ten year cost would be \$105 million. The endowment tax and section 117.d are the top worries.
 - ix. B. Knuth: the elimination of student loan deductions is also very concerning.
 - x. B. Lipinski: what's the easiest way to tell which other schools are affected?
 - xi. J. Malina: if you have graduate student friends at other schools, just assume they will be impacted.
- b. The Senior Leaders Climate Action Group (SLCAG) then made their presentation: Cornell's Annual Sustainability & Climate Action Update.
- i. The powerpoint slides and report are in the meeting packet online (at the end of the packet).
 - ii. Cornell is the top Ivy League institution for sustainability this year
 - 1. Emissions have been reduced 33% since 2008, 50% since 1998.
 - iii. They are working on the next 5 year Campus Sustainability Plan.
 - iv. There are many ways to get involved, for instance you can join one of the many focus teams. You can join their listserv as well, email sustainability@cornell.edu with questions.
 - v. T. McCann: are there plans to include Geneva and Cornell Tech in this?
 - vi. The 2035 Agreement and footprint measuring is for just the Ithaca Campus, though other campuses are doing their own things.
 - vii. M. Battaglia: how are we going to make sure there are sufficient funds to do this down the road?

- viii. The capital cost cap is \$750 million. The main idea is that this won't be funded by Cornell capital. Either something has to have revenue returns or it has to be interesting to government or corporations in order to receive grants.
