Dear Office of the Assemblies:

The Cornell Outing Club is in the process of canvassing signatures to request byline funding from the student activity fee. To do so, they have promised free membership for two years to students delivering 50 signatures (see attached message).

I was an activity chair in the outing club from 2001-2008 and in fact the most active trip leader during that lengthy period when I was a researcher at Cornell. Many things have changed since then:

- * COC has not published minutes of a weekly meeting since 2009 (these minutes included, most critically, "trips announced" and contact people)
- * COC has averaged less than three advertised and structured introductory trips per year since 2009
- * COC has almost entirely replaced its independent student leadership with officers active in Cornell's fee-based outdoor program, Cornell Outdoor Education -- encouraged to do so by COE guidelines which require students developing "outside leadership". The important part is the byline: there is no evidence that COE students in COC have led anything in the better part of a decade.
- * COC has cut meetings in half, from weekly to biweekly (they have little to discuss at more frequent meetings)
- * COC has lost its clubhouse of 70 years, the announcement of the closing coming mere weeks after a Cornell Outdoor Education drafted section of an official university report on minimizing gorge deaths cited the "decrepit condition of the Thurston Ave - Japes Lodge corridor" (Japes Lodge was the former outing club clubhouse).
- * COE is now attempting to obtain resources to build its *own* new management center on the Japes location (they had attempted in the early 1990s to forcibly acquire this property in "nationalizing" the outing club but were rebuffed by alumni outrage).
- * The large collection of gear owned by COC and funded by SAFC has been relocated several times and scattered in the aftermath of the Japes closure, and some remains off-campus. Much has apparently been lost, or "repurposed".
- * The great majority of the few trip announcements on the COC email listserv now are "buddy trips", simply using the COC gear repository for

personal trips, many involving COE personnel who have only limited access to free gear use through COE. Some even request rides from people who are not invited to join the trip.

I encourage the assembly to be critical and thorough in weighing this proposal for by-line funding, which under the current COC regime would essentially be funding private gear for trips of COE student employees and their personal friends.

A precondition for receiving such funding (or indeed, for successful SAFC funding) should be demonstrating a return to *regular*, *advertised*, *organized* trip leading, as shown through regular minutes advertising such trips going out and reporting on previous trips which have occurred.

This structure *would* provide an important service to the student body, as it did for the better part of a century. The current organization of COC provides only a side-benefit to student employees of Cornell Outdoor Education and their friends.
